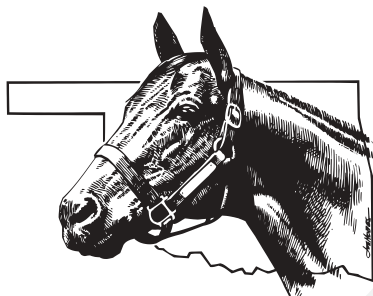

Oklahoma Bred awards paid to 1st-5th places: 45%, 25%, 15%, 10%, 5%

Trials - May 22 & 23, 2007 Finals - June 8 & 9, 2007

Late Provisions:

Double payments to date until February 1, 2007, then payments to date plus \$2,000 until April 1, 2007

Purse Distribution:

38%, 20%, 12%, 8%, 6%, 5%, 4%, 3%, 2%, 2%.

2006 Total Purse - \$130,000

IF A PAYMENT IS MISSED, THAT PAYMENT MUST BE DOUBLED TO REMAIN ELIGIBLE UNTIL 4-1-07. Finalists shall be selected by taking the 10 fastest times. If, for any reason, a tie exists, the horses involved shall draw lots to determine which shall participate in the race. The interest, \$15 per nomination and 15% of the subscription purse will be deducted for operating, promotion, advertising, administration and accounting. OHA reserves the right to reschedule, move, or cancel this race for any reason deemed good or sufficient. *Subject to OHRC approval

It is the responsibility of the owner and/or trainer to make sure their entry is duly registered and eligible by meeting all conditions as published. Should a horse be ineligible and scratched, all fees paid in will be forfeited to the purse and not subject to refund. By making entry into this race I agree to abide by the rules and regulations as published by the OHA, OHRC, Fair Meadows and enforced by the Board of Stewards and to accept their decision as final.
